PE and Sports Premium Funding

What is PE & Sport Premium funding?

The PE & Sports Premium is government funding for schools aimed specifically at making additional and sustainable improvements to the quality of physical education (PE), physical activity and sport.

The premium should be used to:

- Develop or add to the PE, physical activity and sport that school provides;
- Build capacity and capability within the school to ensure that improvements made now will benefit pupils joining the school in future years

In the academic year 2020 – 2021 Keston Primary received £19,500 in addition to 2019/20 carry forward of £9338.81.

The table below shows how this funding was spent:

£7,665.87	Deferred Income to 2021/22 due to Covid school closure – this proportion of the sports funding from 2020/2021 will be used to provide additional swimming provision in small groups to meet the needs of the children and the Covid swimming sessions’ guidance.
